We're pleased to provide you with this Water Quality Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our goal is and always has been, to provide to you a safe and dependable supply of drinking water.

This Water Quality Report shows that your drinking water is safe and meets federal and state requirements.

This report shows the results of our monitoring for the period of January 1st to December 31st 2024. During this time period, the main water source was a well-field located within Hillcrest Estates, Montville, which provides high quality, safe groundwater. The Connecticut Department of Public Health has conducted a water assessment of this well-field. This assessment found that this public drinking water source has a low susceptibility to potential sources of contamination.

Southeastern Connecticut Water Authority (SCWA) has an interconnection with the Hillcrest Water system to the Town of Montville water system. The water supplied via the Town of Montville water system originates from Groton Utilities.

As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In the "Testing Results" table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Non-Detects (ND) - laboratory analysis indicates that the constituent is not present.

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/L) - picocuries per liter is a measure of the radioactivity in water.

Nephelometric Turbidity Unit (NTU) - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The MCL is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The MCLG is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Test Results

The table below lists all of the drinking water contaminants that SCWA sampled for and had analyzed by our certified laboratory, Phoenix Labs. In addition to maximum allowable contaminant levels and the likely sources of contamination, this table lists the highest level detected and the date that the water was sampled. For some contaminants the EPA only requires sampling every three years if the levels detected in the source water are historically low, or not detectable.

<u>Health Effects Statement</u>: Copper is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney damage. People with Wilson's Disease should consult their personal doctor.

<u>Lead - Major Sources in Drinking Water</u>: Corrosion of household plumbing systems; erosion of natural deposits.

Health Effects Statement - Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. SCWA is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water.

Lead Service Line Inventory - The National Primary Drinking Water Regulations for Lead and Copper, which went into effect in 2021, required all public water systems to develop a lead service line (LSL) inventory identifying all materials used to construct or repair all service lines connected to a public water distribution system. Nitrates: As a precaution the local health director is notified if there is a higher than normal level of nitrates in the water supply.

As you can see by the table, our system had no violations. We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some constituents have been detected. The EPA has determined that your water IS SAFE at these levels.

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or manmade. These substances can be microbes, inorganic or organic chemicals and radioactive substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

The water system meets all water quality and water service regulatory requirements. These regulatory requirements involve strict standards, established and monitored by the United States Environmental Protection Agency and the Connecticut Department of Public Health. The water system is very capable; however it does not operate at the extraordinary level that is necessary to provide "fire protection" and/or "fireflow capacity". The SCWA hydrants in your area are used to flush the water mains and are not considered to be "fire hydrants". Municipal fire officials are aware that the water system does not provide fire flows and they do not depend upon it as a fire-fighting tool.

Protection of Water Sources

We ask that all our customers help us protect our water sources, which are essential to quality, safe drinking water. Source water is untreated water from streams, rivers, lakes, or underground aquifers that is used to supply public drinking water. Preventing drinking water contamination at the source makes good public health sense, good economic sense, and good environmental sense. You can be aware of the challenges of keeping drinking water safe and take an active role in protecting drinking water. There are lots of ways that you can get involved in drinking water protection activities to prevent the contamination of the ground water source; properly dispose of household chemicals, help clean up the watershed that is the source of your community's water, and attend public meetings to ensure that the community's need for safe drinking water is considered in making decisions about land use. Water Conservation

We ask that customers use water wisely. Water conservation has far-reaching economic and environmental benefits. SCWA has the long-standing practice of applying a water conservation component to its rate structure. The rate structure has three-tiers, of ascending levels of water conservation premium charges. Conserving water will save you money. Here are a few tips you can follow to help conserve:

- Check for leaky toilets (put a drop of food coloring in the tank, let it sit, if the water in the bowl turns color, you have a leak). A leaking faucet or toilet can dribble away thousands of gallons of water.
- Apply mulch around flowers, shrubs, and vegetables to reduce evaporation, promote plant growth and control weeds. Shrubs and ground covers require less maintenance, less water and provide year-round greenery.
- Be sure that your hose has a shut-off nozzle. Hoses without a nozzle can spout up to 10 gallons per minute.
- When washing your car, wet it quickly, turn off the spray, wash it with soapy water from a bucket, then rinse.
- Be sure sprinklers water only your lawn, not the pavement.
- Never use the hose to clean debris off your driveway or sidewalk. Use a broom.
- Rinse items, such as bicycles or gardening equipment, on the lawn to give your grass an extra drink.
