We're pleased to provide you with this Water Quality Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our goal is to provide to you a safe and dependable supply of drinking water.

This Water Quality Report shows that your drinking water is safe and meets federal and state requirements.

We want our valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled Authority Board meetings. They are held the second Monday of each month at 5:15 PM at 1649 Route 12, Gales Ferry, CT. The meeting schedule for the remainder of 2021 is July 12, August 9, September 13, October 18, November 8, and December 13. Prior to November 10, 2020 the water source for the Gray Division was a well-field located in the Spicer Hill Road and Iron Street area, Ledyard, which provided high quality, safe groundwater. On November 10th the Gray Farms Division became part of the SCWA Ledyard Division, when the newly installed interconnection between these two divisions was opened. The Gray Farms pump station was subsequently closed. The water source for the Ledyard division is a well-field located in Ledyard Design District, Ledyard, which also provides high quality, safe groundwater. The Connecticut Department of Public Health has conducted a water assessment on both of these well-fields. These assessments found that these public drinking water source has a low susceptibility to potential sources of contamination. SCWA routinely monitors for constituents in your drinking water according to Federal and State laws. This report shows the results of our monitoring for the period of January 1st to December 31st, 2020. A table of "Testing Results" identifies those constituents that were detected in SCWA Gray Farm Division water sources. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Non-Detects (ND) - laboratory analysis indicates that the constituent is not present.

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/L) - picocuries per liter is a measure of the radioactivity in water.

Nephelometric Turbidity Unit (NTU) - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The MCL is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The MCLG is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Copper - Major Sources in Drinking Water: Corrosion of household plumbing systems; erosion of natural deposits; leaching from wood preservatives.

Health Effects Statement: Copper is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney damage. People with Wilson's Disease should consult their personal doctor.

Lead - Major Sources in Drinking Water: Corrosion of household plumbing systems; erosion of natural deposits.

Health Effects Statement: Infants and children who drink water containing lead in excess of the action level could experience delays in their physical or mental development. Children could show slight deficits in attention span and learning abilities. Adults who drink this water over many years could develop kidney problems or high blood pressure.

On September 29, 2020 SCWA collected water samples from residences in the Gray Farms Division to be tested for lead and copper. One laboratory analysis of one of these samples indicated an exceedance of the allowable levels for lead, which is 15 parts per billion (ppb), or .015 mg/liter. A public notice was sent to all of the customers of Gray Farms Division on October 6, 2020, and additional lead and copper testing was conducted on October 10, 2020. All of these samples came back with levels well below the allowable levels.

People should not drink or cook with water from the hot water tap. Doing so can result in elevated levels of lead and copper in the water. This is especially significant for young children and anyone with Wilson's Disease.

Nitrates: As a precaution the local health director is notified if there is a higher than normal level of nitrates in the water supply.

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or manmade. These substances can be microbes, inorganic or organic chemicals and radioactive substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Protection of Water Sources

We ask that all our customers help us protect our water sources, which are essential to quality, safe drinking water. Source water is untreated water from streams, rivers, lakes, or underground aquifers that is used to supply public drinking water. Preventing drinking water contamination at the source makes good public health sense, good economic sense, and good environmental sense. You can be aware of the challenges of keeping drinking water safe and take an active role in protecting drinking water. There are lots of ways that you can get involved in drinking water protection activities to prevent the contamination of the ground water source. Properly dispose of household chemicals, help clean up the watershed that is the source of your community's water, and attend public meetings to ensure that the community's need for safe drinking water is considered in making decisions about land use. Water Conservation

We ask that customers use water wisely. Water conservation has far-reaching economic and environmental benefits. SCWA has the long-standing practice of applying a water conservation component to its rate structure. The rate structure has three-tiers, of ascending levels of water conservation premium charges. Conserving water will save you money. Here are a few tips you can follow to help conserve:

- Water shrubs and gardens using a slow trickle around the roots. A slow soaking encourages deep root growth, reduces leaf burn or mildew and prevents water loss. Select low-water demanding plants that provide an attractive landscape without high water use.
- Apply mulch around flowers, shrubs, vegetables and trees to reduce evaporation, promote plant growth and control weeds. Shrubs and ground covers require less maintenance, less water and provide year-round greenery.
- Be sure that your hose has a shut-off nozzle. Hoses without a nozzle can spout up to 10 gallons per minute.
- When washing your car, wet it quickly, turn off the spray, wash it with soapy water from a bucket, then rinse.
